Certified Pediatric Emergency Nurse Review Course

June 2 and June 3, 2016

COURSE DESCRIPTION: Successfully completing the Certified Pediatric Emergency Nurse (CPEN) exam is a challenge that has been completed by only a minority of emergency nurses. This course is a review of emergency nursing designed to assist the participant to be successful in obtaining CPEN certification. The course offers lectures, graphics, videos and practice questions in many of the areas that are tested on the CPEN exam. This review provides a foundation for further study as the participant works toward emergency nursing certification.

TARGET AUDIENCE: **Emergency Department RNs, and all other RNs involved in the care of Pediatric patients.**

OBJECTIVES: At completion of this course the participant will be able to:

- * Recognize & discuss treatment for pediatric emergencies & urgencies, respiratory, cardiovascular, neurological, medical, musculoskeletal, psychosocial, abdominal, genitourinary, environmental, toxicological, allergic reactions, trauma emergencies, or eye, ear, nose & throat (EENT) emergencies.
- * Apply principles of pathophysiology with growth & development consideration to emergent pediatric patients.
- * Identify criteria for evaluating the effectiveness of nursing interventions in pediatric emergencies.
- * Discuss legal concepts of EMTALA, consent & evidence collection in related psychosocial issues, abuse & neglect.
- * List three strategies for successfully preparing for the Certified Pediatric Emergency Nurse (CPEN) Exam.
