Our bargaining team has continued to have productive bargaining with SRSMG. We met virtually on July 22, August 8, and August 19. Here is a summary of our progress to date.

Regarding the Cost of Living Adjustment (COLA):

At the August 19, 2024 virtual bargaining session, we reiterated our position that our union has fully waived any constraints from management in providing a Cost of Living Adjustment (COLA), a custom that has been practiced for years. We sent a letter to management electronically on August 16, 2024 stating that we have no objections to the employer continuing to provide the COLA.
