### ANNOUNCEMENTS

- **RENEW ON TIME: RPh License and BLS/ACLS/ PALS certifications** – **WARNING:** do not work even one day with an expired Pharmacist license or BLS/ACLS/PALS certification **or it can lead to termination.** AHA certification extensions end 10/31/20. Maintaining active licenses and certifications is a requirement of your job. **ARE YOU DUE FOR RENEWAL?**

- **We got a RAISE** – which went into effect October 1, 2020 for all UPSC pharmacists. You will see your new 3% wage increase on your October 23, 2020 paycheck. Retro pay will appear on the following paycheck. UPSC Pharmacist wages are now the HIGHEST in ALL Kaiser Southern and Northern California due to the bargaining power of UNAC/UHCP and the Alliance (LMP). ### LOCAL & REGIONAL CONTRACT ENFORCEMENT

- **Take Charge:** [Click here to view the bi-monthly Take Charge flyer.](#) This month's topic is **Vacation Bidding**.
- **Job Descriptions:** UPSC's grievance over the recent changes in pharmacist job descriptions and qualifications was denied. UPSC was subsequently invited to discuss with management the effects of those changes but it's ultimately management's right to set job requirements.
- **Scheduling:** The agreement to allow managers to post 2-week schedules during COVID19 has expired. **Starting November 1, 4-week schedules must be posted 2 weeks in advance.** This means that a 4-week schedule starting November 1 must be posted by October 18.
- **New Member Program:** UPSC is at the table for discussions around Kaiser initiated pilots in OC and SBC to explore the feasibility of transitioning New Member Program (NMP) work from Amcare to Outpatient. These pilots will look at parameters broadening scope of practice in the OP setting. If successful, current Amcare NMP pharmacists will be retrained to start new services utilizing their valuable clinical skills managing drug utilization in high-dollar biologicals. Kaiser has stated in writing their intent is not for Amcare pharmacists to lose their jobs or alter their FTE status.
- **Mileage:** Riverside stewards filed a grievance for being denied mileage reimbursement to attend Weingarten meetings.

### POLITICAL/LEGISLATION UPDATES

**CALL TO ACTION:** Help UNAC/UHCP enhance voter awareness and participation for the 2020 Presidential

election. UNAC-UHCP is looking for volunteers to place door hangers in members' own neighborhoods to encourage voting. The outcome of this election has far-reaching implications for Affordable Healthcare and the security of unions, among other important issues. - **AB1710 (Wood) PASSED:** This UPSC and CPhA-supported Bill expedites access by pharmacists to COVID-19 vaccines for administration. Once the FDA approves the COVID-19 vaccine, it can go straight to pharmacies to be administered.
